

In Japan, the management of machine tools is subject to regulations based on international regimes for security and export control, and by Japanese laws. Please pay attention in order not to cause any incidents related to security and export control, by understanding the substance of this material.



CAUTION

When your end-user consults you on re-transfer, re-sale or export, etc., please inform your Japan exporter of the machine tool always prior to re-transfer, re-sell, export, etc. of it. Please do not re-transfer re-sell or export it until the Japanese exporter makes their judgement.





If you must transfer the machine tool to evacuate from a natural or man-made disaster




If you want to scrap the machine tool
